Sally Ford-Lyles (SFL) opened the meeting at 10:10. Minutes from the March 12 meeting were approved.

Treasurer's report (Dave Friedlander): Dave reported that our checking balance stands at \$10,791.49 as of the end of March with no checks outstanding. Our savings balance is \$7,017.90 (pending the bank end-of-March statement). The total cash on hand is, therefore, \$17,822.39.

SFL passed around a **sign-up sheet** for the **Spring Show**. Take-in for the show is June 1 from 11:30-12:30 at the Westerville Parks and Recreation Center. The show runs from Thursday, June 2, to Thursday, June 30, with a reception to be held on Sunday, June 5, from 2:00 to 4:00 pm. Second Vice-president John Cameron chairs the committee for this event. Associated with the Spring Show will be the **Spring Weekend Workshop** with **Frank Webb**, June 11-12. It will be held in the Westerville Recreation Program Center, 64 E. Walnut St., behind the Westerville library. The cost is \$135 for COWS members, \$150 for non-members. An information and registration sheet is available for downloading and printing on the society website in the "News and Events" section. SFL will open the workshop to non-members one week from now. The **Fall Workshop** associated with the Fall Show will be taught by juror **Laurie Goldstein-Warren**, who will demonstrate painting city night scenes in transparent watercolor. The 4-day workshop runs from Nov. 15 to 18, at the Broad Street Presbyterian Church, 760 E. SFL urged members to reserve a place soon, as this workshop will fill up quickly. The cost is \$280, and a \$40, non-refundable fee will reserve a place.

At 10:40, SFL introduced Jeff Stahler, whose political cartoons and cartoon panel "Moderately Confused" appear in many newspapers (the *Columbus Dispatch* among them). He currently produces three political cartoons and six "Moderately Confused" panels each week. Jeff discussed his career path and passed around many originals of his cartoons and cartoon sketches. He related some interesting experiences of his life in cartoons, including having once provided a cover for *Newsweek* magazine. His working approach is to draft an idea in pen (a Micron pen) on a half-sheet of letter-size paper, then to finalize his work in ink using a Winsor and Newton Series 7 #2 brush. The final work is sent out electronically and, in some cases, can appear later

that same day. People got a kick (at least I did) out of a recent political cartoon showing a thoroughly disgruntled elephant sitting on the current Supreme Court nominee. He currently enjoys plein air painting in watercolor whenever time permits.
