Important Dates

 - Be sure to include the title of the painting and artist last name in the name of the .JPG file.
- May 20, 2024 Mail your check and completed registration form:

- May 27, 2024, or soon thereafter Notification of acceptance or rejection via email

 - Bring a hard copy of the completed entry form, and tape a label (bottom of the next page) to the back of your painting(s)...
- Sunday, June 2, 2024, 2 to 4pm Reception & Awards, Westerville Community Center
- Saturday, June 29, from 11 am to noon Pick up paintings

Painting Requirements (Please read carefully)

- Eligible Artists: All COWS members in good standing (2024 dues have been paid)
- Original Artwork Only:
 - Copies of other artist's work (including photographs not taken by the artist), or paintings done in workshops, classes, from videos, or from published materials are NOT acceptable
 - o Up to three pieces that have not been shown in previous COWS shows and that have been completed within the last 3 years
 - No nudes or offensive language, words, etc.
- Painting Guidelines (eligibility requirements taken from the Transparent Watercolor Society of America guidelines):
 - Must be transparent watercolor, applied on a single piece of rag or wood pulp paper that is free of pigment and imbedded materials.
 - The following are NOT acceptable: (a) opaque white paint (watercolor, acrylic, gouache) of any kind, such as titanium white, Chinese white, etc.; (b) gesso, matte medium, or any other priming material or exterior surface treatment; (c) gouache, acrylics, or water-soluble oils; Inks, (d) metallic, or iridescent paint or products that leave a metallic, graphite, or reflective sheen (note: some pigments may contain iridescence, e.g.Kyanite, Bronzite, etc., making them ineligible); (e) colored pencil, charcoal, (f) pastel, Conte sticks or Conte crayons; (g) varnish, wax, wax crayon, oil sticks, or oil pastel; (h) collage or surface constructions, (i) impasto, embossing; (j) watercolor resist, such as Frisket, that is not completely removed from the final painting; (k) Yupo or similar papers; (l) canvas or canvas paper; (m) digital images or enhancements printed on the paper.
 - Disputes: The Society Board shall be responsible for ensuring that entries meet the eligibility requirements as stated above. Artists will be notified if their work does not meet the above requirements.

• Frame/Mat:

- All artworks must be clean and in a sturdy frame that is wired at back and ready to hang (no saw tooth hangers)
- White or off-white mats only you may use a colored inner mat.
- Plexiglass only, no glass.
- o No size limit

Pricing and Sales

- Art does not need to be for sale
- Potential purchasers will contact the artist directly.
- Once your painting has been accepted, you may not substitute another work, modify the painting in any way, or change the sale price.
- No artwork may be withdrawn or removed from the show before the end of the show.
- All submitted artworks will be juried and judged for inclusion in the show and for awards.
